

OFFICIAL RULES GMC ULTIMATE TAILGATE PACKAGE SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: The GMC Ultimate Tailgate Package Sweepstakes (the "Sweepstakes") begins on September 13, 2020, at 12:00 AM Eastern Daylight-Saving Time ("EDT") and ends on January 3, 2021, at 11:59 PM Eastern Daylight-Savings Time ("EDT") (the "Sweepstakes Period"). Administrator's computer will be the official time-keeping device for the Sweepstakes. **Grand Prize Drawing event will take place and be determined in January 2021 and following the final Carolina Panthers home game of the NFL season.**

ELIGIBILITY: THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF THE STATES OF NORTH CAROLINA AND SOUTH CAROLINA WHO ARE EIGHTEEN (18) YEARS OF AGE OR OLDER AT THE TIME OF ENTRY AND HAVE A VALID DRIVER'S LICENSE ("ENTRANT"). ALL OTHERS ARE INELIGIBLE TO ENTER OR WIN AND WILL BE DISQUALIFIED. VOID WHERE PROHIBITED OR RESTRICTED. Employees of Carolina BPG LMA, Inc., Piedmont Triad BPG LMA, Inc., Carolina Buick Pontiac GMC Local Marketing Association, Inc., Cape Fear Area Buick Pontiac GMC Dealers Local Marketing Association, Inc., ("Co-Sponsors"), EventLink LLC ("Administrator"), Jack Morton Worldwide, Panthers Football, LLC, Panthers Stadium, LLC, and NFL Entities (as defined below), and their respective officers, directors, agents, parents, affiliates, subsidiaries, dealerships and advertising and promotion agencies, and the members of their immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household with such individuals (whether related or not), are not eligible to enter or win.

No other method of entry will be accepted. Non-winning Entries will not roll over into the next entry period. Co-Sponsors are not responsible for lost, late, illegible, stolen, incomplete, invalid or unintelligible entries. Proof of submission will not be deemed proof of receipt by Co-Sponsors. Co-Sponsors may not display at all events and locations and reserves the right to add, change, and/or cancel, its intentions to display at any or all of the below listed locations, at any time, without notice.

ON-SITE ENTRY: Visit the GMC display area at selected Carolina Panthers home games at Bank Of America Stadium in Charlotte, North Carolina during the Sweepstakes Period and complete the official entry form, available while supplies last, by providing the requested contact information (including zip code) ("On-Site Entry"). On-Site entries must be received prior to the display closing.

DEALERSHIP ENTRY: Visit one of the participating Dealerships' during the Sweepstakes Period and during regular posted dealer hours and complete the Official Entry Form by providing the requested information ("Dealership entry"). DEALERSHIP ENTRIES MUST BE RECEIVED BY January 3, 2021 BY 11:59 P.M. EDT, or by posted closing time of the Dealership. There is a limit of one (1) entry per person, per week through the Dealership entry method regardless of location entering.

ON-LINE ENTRY: To enter the Sweepstakes, visit the Carolina Panthers app (the "website") and participate in the GMC in-app game during the Promotional Period and follow the provided instructions to complete and thereafter submit the entry form with the required contact information (which includes full name, complete mailing address, phone number, and email address) and submit as directed ("On-Line Entry"). ON-LINE ENTRIES MUST BE SUBMITTED BY 11:59 EDT on January 3, 2021.

On-Site, Dealership, On-Line, and Mail-In entries are hereinafter referred to as "Entry" or "Entries."

LIMIT: THERE IS A LIMIT OF ONE (1) ENTRY PER PERSON, PER WEEK, REGARDLESS OF METHOD OF ENTRY. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Any potential winner may be required to show proof of being the authorized account holder. No mechanical reproductions of entry forms permitted. FIRST PRIZE WEEKLY WINNER SELECTION: Administrator will select, via a random drawing per the drawing schedule above, one (1) Potential Weekly First Prize Winner ("Weekly Winner"), from among all eligible entries received during that Entry Period, subject to verification and compliance with these Official Rules for a total of eight (8) potential Weekly Winners. All eight (8) Weekly Entry Period Winners will receive, in addition to the Weekly Prize listed below, an opportunity to attend the Carolina Panthers Private Pep Rally, and a chance to win the Grand Prize. Each potential Winner will be contacted by the Administrator by telephone and/or email and will be required to complete and return an affidavit of eligibility, liability, and use of likeness release, and except where prohibited by law, a publicity release form ("affidavit/release") within three (3) days of receipt.

Weekly Entry Period Winners one through eight (1-8) ("Finalist" or "Finalists") will also be invited to attend the Carolina Panthers Private Pep Rally and will have an opportunity to win the Grand Prize. Each guest of Finalist must be at least 18 years of age or the age of majority in their state of residence, unless child or legal ward of Finalist, and may also be required to sign releases and waiver forms. If any of the potential Weekly Winner's notifications are rejected, returned, or deemed undeliverable or a potential Weekly Winner fails to execute and return the affidavit/release within the specified time or if he/she is otherwise ineligible to receive the prize, that potential Weekly Winner will be deemed ineligible and a replacement may be randomly selected by Administrator from among the remaining eligible Entries, time permitting.

It is anticipated that there will be a total of eight (8) Finalists, but this number could change based on various factors such as a Finalist being deemed ineligible, unable to attend the Grand Prize drawing, or changes to the NFL schedule.

FINALIST PRIZE AND GRAND PRIZE EVENT /ODDS: In addition to the above Weekly Prize, the eight (8) Finalists will each receive:

- An Opportunity to attend the Carolina Panthers Private Pep Rally Grand Prize Drawing Event with date to be determined after the final Carolina Panthers home game of the NFL season, which is currently scheduled for January 3, 2021, unless the game is altered or delayed due unforeseen circumstances, including a public health crisis (e.g. COVID-19) or some other unforeseen event.

Additional expenses, including travel to/from the Private Pep Rally, parking fees, taxes, or other fees and costs not explicitly mentioned, are not included in the Finalist Prize and will be the responsibility of the Finalist. Co-Sponsors, in their sole discretion, will determine seating locations and details.

If a Finalist does not attend the Grand Prize Drawing event for any reason, he or she is allowed one (1) designated proxy to represent them at the Grand Prize Drawing event. EDT. **FINALIST OR DESIGNATED PROXY MUST BE PRESENT AT GRAND PRIZE DRAWING EVENT TO WIN THE GRAND PRIZE AND FINALIST IS RESPONSIBLE FOR ALL TRAVEL COSTS ASSOCIATED WITH THE FINALIST/DESIGNATED PROXY'S ATTENDANCE.** Finalists cannot transfer their chance to win the Grand Prize to another individual.

The odds of a particular Entrant winning a Prize depends on the number of eligible entries received for each Entry Period.

GRAND PRIZE WINNER SELECTION/VERIFICATION: It is anticipated that there will be a total of eight (8) Finalists for the Grand Prize Drawing event, but this number could change based on various factors such as a Finalist being unable to attend or changes to the NFL schedule due to COVID-19. Each of the up to eight (8) Finalists, or designated proxy, must personally appear and present themselves to an Administrator and/or a Co-Sponsor representative at the Grand Prize Drawing event that will be determined by the Co-Sponsor and/or Administrator after the final Carolina Panthers home game of NFL season, which is currently scheduled for January 3, 2021 unless the game is delayed or altered due to epidemic, pandemic, public health crisis (e.g. COVID-19) or other circumstance beyond Sponsor's control, in which case Sponsor will inform Finalists of the new Private Pep Rally date and time. Co-Sponsor's also reserve the right, in their sole discretion, to alter the Grand Prize Drawing Event, including by hosting it virtually. All eight (8) finalists must present a valid government-issued photo identification for registration. Finalists, or designated proxy, must fill out any and all registration and waiver forms required by Administrator/Sponsor. Any Finalists, or designated proxy, who do not present themselves to an Administrator and/or Sponsor representative for registration by the time specified may be disqualified and not replaced at the sole discretion of Administrator or Sponsor. The Grand Prize Winner will then be selected in a random drawing event conducted by a representative of the Co-Sponsors from among all eligible Finalists, or designated proxy, who are present at the Drawing (the "Potential Grand Prize Winner").

Potential Grand Prize Winner will be required to complete and return an affidavit of eligibility, liability release, and except where prohibited by law, a publicity release form ("affidavit/release") within five (5) days of receipt. GRAND PRIZE/ODDS: Grand Prize consists of \$55,000 to be applied toward the purchase of a new 2020 or 2021 GMC Sierra (the "Vehicle"). If the Vehicle's MSRP is under \$55,000 the Grand Prize Winner will not be awarded the difference between the vehicle's actual MSRP and \$55,000. Grand Prize Winner is solely responsible for any expenses in connection with acceptance and use of the Vehicle not expressly described herein as being awarded, including, without limitation, the following: (i) income, federal, state or local taxes; (ii) insurance, registration fees, dealer preparation fees and/or additional options, additions or equipment; and (iii) any additional expenses not described herein as being awarded, including, without limitation, any travel or transportation costs, associated with winning and subsequent use of Vehicle. All options and upgrades on Vehicle that increase the MSRP over \$55,000 are the sole responsibility of Grand Prize Winner. Grand Prize Winner must personally retrieve Vehicle within (30) days of written notification of delivery and must present a valid U.S. driver's license issued in his/her state of residence and proof of insurance to take delivery. In the event that the potential winner is disqualified for any reason, the prize may not be awarded.

No cash or Vehicle substitutes and no cash rebates. Vehicle cannot be assigned or transferred to a third party. Vehicle delivery is through an authorized GMC dealer and conditional upon Grand Prize Winner's execution and return of any and all required paperwork. Released Parties (defined below) will not be responsible for weather conditions, Acts of God, acts of terrorism, civil disturbances, epidemic, public health crisis (e.g. COVID-19), work stoppage or any other natural disaster outside their control that may cause the cancellation or postponement of any NFL game, event, Private Pep Rally, or exhibition. Event and exhibition tickets awarded as prizes may not be resold or offered for resale. Any such resale may result in disqualification and Prize forfeiture and may invalidate the license granted by the ticket(s).
