

OFFICIAL RULES

BECKER PREMIUM QUARTERLY SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE BECKER PREMIUM QUARTERLY SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 10:00 A.M. CENTRAL TIME ("CST") ON FEBRUARY 8, 2021, AND ENDS ON JANUARY 2, 2022, AT 11:59 P.M., CST (THE "PROMOTIONAL PERIOD"). ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES.

ELIGIBILITY: THE GIVEAWAY IS OPEN ONLY TO THOSE WHO ARE LEGAL RESIDENTS IN ONE OF THE 50 UNITED STATES OR DISTRICT OF COLUMBIA AND ARE AT LEAST 18 YEARS OF AGE OR OLDER WITH A VALID DRIVER'S LICENSE AND INSURANCE (EXCEPT IN THE CASE OF LEGAL RESIDENTS OF CERTAIN STATES WHERE THE LEGAL AGE OF MAJORITY IS GREATER THAN 18 YEARS OF AGE, SUCH LEGAL AGE OF MAJORITY) AT THE TIME OF ENTRY (COLLECTIVELY AN "ENTRANT" OR "ENTRANTS"). VOID WHERE PROHIBITED OR RESTRICTED. Employees of Becker ("Sponsor"), EventLink LLC ("Administrator"), and their respective parents, affiliates, subsidiaries, dealerships, distributors, and their advertising and promotion agencies and the members of their immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household with such individuals (whether related or not) are not eligible to enter or win.

TO ENTER: There are two (2) ways to enter the Sweepstakes during the Promotional Period: at Designated Events as described below and mail-in. No other methods of entry will be accepted. Non-winning Entries will roll over into the next entry period. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid or unintelligible entries. Proof of submission will not be deemed proof of receipt by Sponsor. Sponsor may not display at all events and locations and reserves the right to add, change, and/or cancel, its intentions to display at any or all of the below listed locations, at any time, without notice. There will be one (1) Grand Prize Winner and ten (10) Sweepstakes Themed Prize Winners, per Entry Period, determined by random drawing from all eligible Entries received during the applicable Entry Period from all methods and points of entry. Entries must be received during an Entry Period and prior to the drawing time to be eligible for that Entry Period's drawing.

DESIGNATED EVENTS: Throughout the Promotional Period, Sponsor will display at various in-person and virtual events where Sponsor will make Sweepstakes entries available. To enter, Entrants should be in attendance at those eligible events

and visit the Becker display that will be at various in-person and virtual events along with webcasts throughout the year starting from February 8, 2021, through January 2, 2022. Sponsor may not display at the event and reserves the right to add, change and/or cancel its intentions to display at the above location, at any time, without notice. Entrants will be asked to provide first and last name, phone number and email address. Entrants may also be asked to answer optional questions; however, they need not be answered in order to be eligible for the Sweepstakes.

WINNER SELECTION: There will be a total of, and no more than, forty-four (44) Sweepstakes Prize Winners. Administrator will select, via a random drawing per the drawing schedule above, one (1) Potential Drawing Period Grand Prize Winner ("Grand Prize Winner") and ten (10) potential Themed Prize Winners ("Theme Prize Winner") from among all eligible entries received during that Entry Period, subject to verification and compliance with these Official Rules, for a total of eleven (11) potential Entry Period Winners. If Sponsors or Administrator, in their sole discretion, elects to abbreviate the Sweepstakes as a result of a Force Majeure event, Sponsors and/or Administrator reserves the right, to award prizes from among all the eligible entries received up to the date of such Force Majeure event. Sponsors and Administrator also reserve the right, in their sole discretion, to cancel, modify or suspend the Sweepstakes in whole or in part, in the event of fraud, technical or other difficulties or if the integrity of the Sweepstakes is compromised, without liability to any entrant. Entries not complying with all rules are subject to disqualification. Administrator reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. If any provision(s) of these Official Rules is held invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.

ARBITRATION: By participating in this Sweepstakes, each Entrant agrees: (i) that any and all disputes the entrant may have with, or claims entrant may have against, the Released Parties relating to, arising out of or connected in any way with (a) the Sweepstakes, (b) the awarding or redemption of any prize, and/or (c) the determination of the scope or applicability of this agreement to arbitrate, will be resolved exclusively by final and binding arbitration administered by JAMS and conducted before a sole arbitrator in accordance with the rules of JAMS; (ii) this arbitration agreement is made pursuant to a transaction involving interstate commerce, and shall be governed by the Federal Arbitration Act ("FAA"), 9 U.S.C. §§ 1-16; (iii) the arbitration shall be held in Cook County, Illinois; (iv) the arbitrator's decision shall be controlled by the terms and conditions of these Official Rules and any of the other agreements referenced herein that the applicable

If, however, subpart (vi) is found to be invalid, unenforceable or illegal, then the entirety of this arbitration provision shall be null and void, and neither entrant nor Sponsor shall be entitled to arbitrate their dispute. CHOICE OF LAW: By entering this Sweepstakes, participant's agree that all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, participants' rights and obligations, the rights and obligations of Sponsor and any and all claims arising out of or related to or in connection with the Sweepstakes shall be governed by and construed in accordance with the laws of the State of Illinois, without giving effect to any choice of law or conflict of law provisions (whether of the State of Illinois or any other jurisdiction) which would cause the application of the laws of any jurisdiction other than the State of Illinois.
