

OFFICIAL RULES

RACE FAN SWEEPSTAKES-ORLANDO

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. RACE FAN SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 10:00 A.M. ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES.
