PACIFIC TIME ("PT") ON MAY 26, 2023, AND ENDS ON JUNE 28, 2023, AT 11:59 P.M., PST (THE "PROMOTIONAL PERIOD"). ODDS OF WINNING DEPEND ON TOTAL NUMBER OF ELIGIBLE ENTRIES. ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES.
