If you are a Minor, you must also have your parent or legal guardian agree to the Terms and Conditions and the Official Rules by electronically signing the Application. You are considered a "Minor" for purposes of the Contest if, at the time of entry, you are under 18 years of age. Entry Deadline: ENTRIES MUST BE SUBMITTED BY 11:59 P.M. CT ON FEBRUARY 29, 2024. WINNER SELECTION: Winner selection period will run March 1, 2024 and ends on March 14, 2024 at 11:59 P.M. CT. Fifteen (15) "Semi-Finalists" will be selected from the qualified nominations received by the entry deadline by a panel of judges consisting of (5) five members of the Administrator beginning on March 1, 2024. Semi-Finalists will be asked to fill out a release form to participate as a Semi-Finalists. Judges will select the Semi-Finalists based on the following: their community, volunteer, academic and extracurricular activities, as well as academic achievement. The fifteen (15) Semi-Finalists will then be narrowed down to six (6) "Finalists" by the West Dakota Chevy Dealers Advertising Association Executive Board of Directors. The Board of Directors will choose the Finalists based on whom they deem the most well-rounded students based on their community, volunteer, academic, application materials, and extracurricular activities. Out of the five (5) categories listed, finalists can receive up to twenty (20) points per category. The Board of Directors panel will rate each student finalist from zero (0) to twenty (20) in each category to determine the Grand Prize winner and Runner Up winners. The Student with the most points will be judged the Winner of the Grand Prize (subject to verification)

FINALISTS REVEAL DATES: On March 27, 2024 at 4:00 P.M. CT through March 31, 2023, at 4:00 P.M. CT the Sponsor will reveal a Finalist in no particular order. On April 1, 2024, the Sponsor will reveal the Grand Prize winner for the \$5,000 prize.
